The Consultants will also frequently work at the Programmes Regional Coordination Unit at Mauritius.

Minimum Qualifications:

- Citizen of an EU country actually contributing to 9th EDF or of ACP state, preferably of ReCoMaP's core beneficiary countries listed above
- University degree (bachelor or higher) depending on the desired position as stated above
- 5 years of relevant experience, including work experience at government and/or non-government planning levels and with local communities (Lagoon Resources Specialist);
- Experience in GIS and in the application of data management would be a clear advantage;
- Ability to work effectively with government officials, local communities, NGOs and the private sector;
- Ability to work in a concerted team and to follow clearly defined methodical schemes and procedures;
- Fluency in English and a reasonable working knowledge of French, spoken and written;
- Computer literacy including word processing (e.g. MS Word®), spreadsheet software (e.g. MS Excel®), and presentation and visualisation tools (e.g. MS PowerPoint®);
- Outstanding interpersonal skills and a high level of autonomy, initiative and creativity;
- Ability and willingness to work and to travel in the Programme's beneficiary countries
